Mr. Vincent H. S. Lo Speaks at “Distinguished Speakers Series” Luncheon of The Chamber of Hong Kong Listed Companies

(Wednesday, 28 May 2008) The Chamber of Hong Kong Listed Companies (the “Chamber”) welcomed Mr. Vincent H. S. Lo, GBS, Chairman & Chief Executive Officer of Shui On Land Limited at its “Distinguished Speakers Series” Luncheon held today.

At the luncheon, Mr. Lo delivered a speech entitled “**Corporate Governance for Company’s Sustainable Growth**” to over 100 guests from Hong Kong listed companies.
